Preliminary Remarks

Under the BSIG¹ Act, the Federal Office for Information Security (BSI) has the task of issuing certificates for information technology products.

Certification of a product is carried out on the instigation of the vendor or a distributor, hereinafter called the sponsor.

A part of the procedure is the technical examination (evaluation) of the product according to the security criteria published by the BSI or generally recognised security criteria.

The evaluation is normally carried out by an evaluation facility recognised by the BSI or by BSI itself.

The result of the certification procedure is the present Certification Report. This report contains among others the certificate (summarised assessment) and the detailed Certification Results.

The Certification Results contain the technical description of the security functionality of the certified product, the details of the evaluation (strength and weaknesses) and instructions for the user.

A. Certification

1. Specifications of the Certification Procedure

The certification body conducts the procedure according to the criteria laid down in the following:

- Act on the Federal Office for Information Security²
- BSI Certification and Approval Ordinance³
- BSI Schedule of Costs⁴
- Special decrees issued by the Bundesministerium des Innern (Federal Ministry of the Interior)
- DIN EN ISO/IEC 17065 standard
- BSI certification: Scheme documentation describing the certification process (CC-Produkte) [3]
- BSI certification: Scheme documentation on requirements for the Evaluation Facility, its approval and licencing process (CC-Stellen) [3]
- Common Criteria for IT Security Evaluation (CC), Version 3.1⁵ [1] also published as ISO/IEC 15408.
- Common Methodology for IT Security Evaluation (CEM), Version 3.1 [2] also published as ISO/IEC 18045.
- BSI certification: Application Notes and Interpretation of the Scheme (AIS) [4]

2. Recognition Agreements

In order to avoid multiple certification of the same product in different countries a mutual recognition of IT security certificates - as far as such certificates are based on ITSEC or CC - under certain conditions was agreed.

2.1. European Recognition of ITSEC/CC – Certificates (SOGIS-MRA)

The SOGIS-Mutual Recognition Agreement (SOGIS-MRA) Version 3 became effective in April 2010. It defines the recognition of certificates for IT-Products at a basic recognition level and, in addition, at higher recognition levels for IT-Products related to certain SOGIS Technical Domains only.

The basic recognition level includes Common Criteria (CC) Evaluation Assurance Levels EAL 1 to EAL 4 and ITSEC Evaluation Assurance Levels E1 to E3 (basic). For "Smartcards and similar devices" a SOGIS Technical Domain is in place. For "HW Devices with Security Boxes" a SOGIS Technical Domains is in place, too. In addition, certificates issued for Protection Profiles based on Common Criteria are part of the recognition agreement.

The new agreement has been signed by the national bodies of Austria, Finland, France, Germany, Italy, The Netherlands, Norway, Spain, Sweden and the United Kingdom. The current list of signatory nations and approved certification schemes, details on recognition, and the history of the agreement can be seen on the website at <https://www.sogisportal.eu>.

The SOGIS-MRA logo printed on the certificate indicates that it is recognised under the terms of this agreement by the nations listed above.

This certificate is recognized under SOGIS-MRA for all assurance components selected.

2.2. International Recognition of CC – Certificates (CCRA)

The international arrangement on the mutual recognition of certificates based on the CC (Common Criteria Recognition Arrangement, CCRA-2014) has been ratified on 08 September 2014. It covers CC certificates based on collaborative Protection Profiles (cPP) (exact use), CC certificates based on assurance components up to and including EAL 2 or the assurance family Flaw Remediation (ALC_FLR) and CC certificates for Protection Profiles and for collaborative Protection Profiles (cPP).

The CCRA-2014 replaces the old CCRA signed in May 2000 (CCRA-2000). Certificates based on CCRA-2000, issued before 08 September 2014 are still under recognition according to the rules of CCRA-2000. For on 08 September 2014 ongoing certification procedures and for Assurance Continuity (maintenance and re-certification) of old certificates a transition period on the recognition of certificates according to the rules of CCRA-2000 (i.e. assurance components up to and including EAL 4 or the assurance family Flaw Remediation (ALC_FLR)) is defined until 08 September 2017.

As of September 2014 the signatories of the new CCRA-2014 are government representatives from the following nations: Australia, Austria, Canada, Czech Republic, Denmark, Finland, France, Germany, Greece, Hungary, India, Israel, Italy, Japan, Malaysia, The Netherlands, New Zealand, Norway, Pakistan, Republic of Korea, Singapore, Spain, Sweden, Turkey, United Kingdom, and the United States.

The Common Criteria Recognition Arrangement logo printed on the certificate indicates that this certification is recognised under the terms of this agreement by the nations listed above.

This certificate is recognized according to the rules of CCRA-2014, i.e. up to and including CC part 3 EAL 2 components. The evaluation contained components that are not mutually recognised in accordance with the provisions of the CCRA-2014:

For mutual recognition the EAL 2 components of these assurance families are relevant.

3. Performance of Evaluation and Certification

The certification body monitors each individual evaluation to ensure a uniform procedure, a uniform interpretation of the criteria and uniform ratings.

The product NXP Secure Smart Card Controller P6022y VB including IC Dedicated Software has undergone the certification procedure at BSI. This is a re-certification based on BSI-DSZ-CC-0973-2016. Specific results from the evaluation process BSI-DSZ-CC-0973-2016 were re-used.

The evaluation of the product NXP Secure Smart Card Controller P6022y VB including IC Dedicated Software was conducted by TÜV Informationstechnik GmbH. The evaluation was completed on 15 September 2016. TÜV Informationstechnik GmbH is an evaluation facility (ITSEF)⁶ recognised by the certification body of BSI.

For this certification procedure the sponsor and applicant is: NXP Semiconductors Germany GmbH.

The product was developed by: NXP Semiconductors Germany GmbH.

The certification is concluded with the comparability check and the production of this Certification Report. This work was completed by the BSI.

4. Validity of the Certification Result

This Certification Report only applies to the version of the product as indicated. The confirmed assurance package is only valid on the condition that

- all stipulations regarding generation, configuration and operation, as given in the following report, are observed,
- the product is operated in the environment described, as specified in the following report and in the Security Target.

For the meaning of the assurance levels please refer to the excerpts from the criteria at the end of the Certification Report or in the CC itself.

The Certificate issued confirms the assurance of the product claimed in the Security Target at the date of certification. As attack methods evolve over time, the resistance of the certified version of the product against new attack methods needs to be re-assessed. Therefore, the sponsor should apply for the certified product being monitored within the assurance continuity program of the BSI Certification Scheme (e.g. by a re-certification). Specifically, if results of the certification are used in subsequent evaluation and certification procedures, in a system integration process or if a user's risk management needs regularly updated results, it is recommended to perform a re-assessment on a regular e.g. annual basis.

In order to avoid an indefinite usage of the certificate when evolved attack methods require a re-assessment of the products resistance to state of the art attack methods, the maximum validity of the certificate has been limited. The certificate issued on 11 October 2016 is valid until 10 October 2021. Validity can be re-newed by re-certification.

1. when advertising the certificate or the fact of the product's certification, to refer to the Certification Report as well as to provide the Certification Report, the Security Target and user guidance documentation mentioned herein to any customer of the product for the application and usage of the certified product,
2. to inform the Certification Body at BSI immediately about vulnerabilities of the product that have been identified by the developer or any third party after issuance of the certificate,
3. to inform the Certification Body at BSI immediately in the case that security relevant changes in the evaluated life cycle, e.g. related to development and production sites or processes, occur, or the confidentiality of documentation and information related to the Target of Evaluation (TOE) or resulting from the evaluation and certification procedure where the certification of the product has assumed this confidentiality being maintained, is not given any longer. In particular, prior to the dissemination of confidential documentation and information related to the TOE or resulting from the evaluation and certification procedure that do not belong to the deliverables according to the Certification Report part B, or for those where no dissemination rules have been agreed on, to third parties, the Certification Body at BSI has to be informed.

In case of changes to the certified version of the product, the validity can be extended to the new versions and releases, provided the sponsor applies for assurance continuity (i.e. re-certification or maintenance) of the modified product, in accordance with the procedural requirements, and the evaluation does not reveal any security deficiencies.

B. Certification Results

The following results represent a summary of

- the Security Target of the sponsor for the Target of Evaluation,
- the relevant evaluation results from the evaluation facility, and
- complementary notes and stipulations of the certification body.

1. Executive Summary

The Target of Evaluation (TOE) is the IC hardware platform NXP Secure Smart Card Controller P6022y VB with IC Dedicated Software and documentation describing the Instruction Set and the usage with “y” as placeholder for

- P: Plain, no emulation.
- X: Plain, no emulation, extended memory (ROM)
- M: MIFARE Plus/Classic implementation.
- D: MIFARE DESFire EV1 implementation.
- J: joint MIFARE Plus/Classic/DESFire EV1 implementation.

The IC hardware platform NXP Secure Smart Card Controller P6022y VB is a microcontroller incorporating a central processing unit, memories accessible via a Memory Management Unit, cryptographic co-processors, other security components and two communication interfaces. The central processing unit supports a 32-/24-/16-/8-bit instruction set optimized for smart card applications, which is a super set of the 80C51 family instruction set. On-chip memories are ROM, RAM and EEPROM. The non-volatile EEPROM can be used as data or program memory.

The IC Dedicated Software comprises IC Dedicated Test Software for test purposes and IC Dedicated Support Software. The IC Dedicated Support Software consists of Boot-ROM Software controlling the boot process of the hardware platform and Firmware Operating System which can be called by the Security IC Embedded Software.

Except for the y=P and y=X configurations the P6022y VB includes Emulation Software MIFARE Plus MF1PLUSx0 and/or MIFARE DESFire EV1. In case of y=X, the TOE provides extended EEPROM memory (optimized memory to free-up additional ROM for application OS).

The P6022y VB can be used to assure authorized conditional access in a wide range of applications. Examples are identity cards, Banking Cards, Pay-TV, Portable communication SIM cards, Health cards and Transportation cards.

The Security Target [6] is the basis for this certification. It is based on the certified Protection Profile Security IC Platform Protection Profile with Augmentation Packages Version 1.0, 13 January 2014, BSI-CC-PP-0084-2014 [8].

The TOE Security Assurance Requirements (SAR) are based entirely on the assurance components defined in Part 3 of the Common Criteria (see part C or [1], Part 3 for details). The TOE meets the assurance requirements as defined by the Evaluation Assurance Level depending on the configuration of the TOE:

- **P6022P/X VB**
EAL6 augmented by ALC_FLR.1, ASE_TSS.2
- **P6022M/D/J VB**
EAL 5 augmented by AVA_VAN.5, ALC_DVS.2, ASE_TSS.2

The TOE Security Functional Requirements (SFR) relevant for the TOE are outlined in the Security Target [6] and [9], chapter 6. They are selected from Common Criteria Part 2 and some of them are newly defined. Thus the TOE is CC Part 2 extended.

This certification covers the configurations of the TOE as outlined in chapter 8.

The vulnerability assessment results as stated within this certificate do not include a rating for those cryptographic algorithms and their implementation suitable for encryption and decryption (see BSIG Section 9, Para. 4, Clause 2).

The requirements for the delivery of TOE are described in the “Product Data Sheet” chapter 31 and the requirements for the delivery itself are given in the “Wafer and delivery specification” chapter 4. For each delivery form of the hardware platform NXP offers two ways of delivery of the TOE:

1. The customer collects the product himself at the NXP site, or

2. the product is sent to the customer by NXP. The delivery is protected by special measures.

The commercial type name is the identification used to order the TOE P6022y VB in the respective major configuration and with the evaluated package type. In consequence this means that a full commercial product name that fits in the variable forms described in the Security Target determines that the hardware platform is an evaluated product.

3. Security Policy

The Security Policy is expressed by the set of Security Functional Requirements and implemented by the TOE. It covers the following issues:

The Security Policy of the TOE is to provide basic security functionalities to be used by the smart card operating system and the smart card application thus providing an overall smart card system security. Therefore, the TOE will implement the symmetric cryptographic block cipher algorithm to ensure the confidentiality of plain text data by encryption and to support secure authentication protocols and it will provide a True Random Number Generator (TRNG).

As the TOE is a hardware security platform, the security policy of the TOE is also to provide protection against leakage of information (e.g. to ensure the confidentiality of cryptographic keys during cryptographic functions performed by the TOE), against physical probing, against malfunctions, against physical manipulations and against abuse of functionality. Hence the TOE shall

- maintain the integrity and the confidentiality of data stored in the memory of the TOE and
- maintain the integrity, the correct operation and the confidentiality of security functionalities (security mechanisms and associated functions) provided by the TOE.

Specific details concerning the above mentioned security policies can be found in chapter 7 of the Security Target [6] and [9].

4. Assumptions and Clarification of Scope

The Assumptions defined in the Security Target and some aspects of Threats and Organisational Security Policies are not covered by the TOE itself. These aspects lead to specific security objectives to be fulfilled by the TOE-Environment. The following topics are of relevance:

Details can be found in the Security Target [6] and [9], chapters 4.2 and 4.3.

5. Architectural Information

The TOE consists of the following hardware

- CPU / co-processors:
 - a CPU implementation supporting a 32-/24-/16-/8 bit instruction set which is a superset of the 80C51 family instruction set and distinguishes five CPU modes,
 - a Triple-DES co-processor, supporting single DES and Triple-DES operations (in 2-key or 3-key operation, with two/three 56 bit keys (112-/168 bit)), where only Triple-DES operations are evaluated and considered as security functionality,
 - an Advanced Encryption Standard (AES) co-processor with key lengths of 128, 192 and 256 bits,
 - an arithmetic co-processor, called Fame2 co-processor, whose availability is subject to specific choice of Customer Reconfiguration Options. It supplies basic arithmetic functions to support implementation of asymmetric cryptographic algorithms by the Security IC Embedded Software; the Security IC Embedded Software is not part of the TOE,
 - a CRC co-processor, providing the CRC generation polynomials CRC-16 and CRC-32 for hardware cyclic redundancy check calculations,
- Memory / Memory Controller:
 - Read-Only Memory (ROM): the TOE incorporates – depending of the selected major configuration – 714 kBytes (P6022X VB), 640 kBytes(P6022P VB) or 512 kBytes (P6022M/D/J VB) of ROM, where 1 kByte = 1024 Bytes. The ROM is partitioned by a Memory Management Unit (MMU) into 128 kBytes reserved for the Test-ROM, Boot-ROM and Firmware including emulations. The remaining ROM is used as Application-ROM for the Security IC Embedded Software,
 - Random Access Memory (RAM): 11968 Bytes of RAM, which is parted into RAM available to the Firmware Operating System only (576 Bytes), Application-RAM which is available to the Security IC Embedded Software and is split into 2.688

Bytes for the Fame2 coprocessor, called FXRAM, and 8704 Bytes general purpose RAM, called CXRAM,

- Electrically Erasable Programmable Read Only Memory (EEPROM): Provides 144 KBytes of EEPROM, where 1024 Bytes are always reserved for IC Dedicated Support Software for FOS control data, 512 Bytes for the manufacturer area, 768 Bytes for the PUF Block and the remaining part is reserved for MIFARE software part of the IC Dedicated Support Software.
- Memory Controller: A Memory Management Unit (MMU) controls access to all of the three above mentioned memory types, and
- Copy Machine: a device providing direct memory access for the Security IC Embedded Software without CPU interactions.
- Internal Peripherals:
 - a True Random Number generator,
 - A PUF (Physically Unclonable Function) block,
 - a Watchdog timer, configurable by the Security IC Embedded Software to protect program execution,
 - timers,
 - reset generator.
- Physical protection:
 - secure shielding,
 - security sensors with reset generator,
- Electrical interfaces:
 - ISO/IEC 14443 A contactless interface with pads LA and LB, whose availability is subject to a minor configuration option,
 - ISO/IEC 7816 contact interface with serial communication pad I/O1,
 - single external power supply of 1.8 V, 3 V or 5 V nominal by the lines VDD and VSS, or supply by inductive coupling via the ISO/IEC 14443 A contactless interface,
 - clock input CLK with a clock filter and clock generator,
 - reset input RST_N.

The TOE consists of the following firmware:

- Security IC Dedicated Test Software, which is stored to the Test-ROM and used by the manufacturer of the Security IC during production test; it includes the test operating system, test routines for the various blocks of the circuitry, control flags for the status of the EEPROM's manufacturer area and shutdown functions,
- Security IC Dedicated Support Software, according to
 - Boot-ROM Software, executed during start-up,
 - The Firmware Operating System (FOS) provides an interface for the Security IC Embedded Software. This interface is called FVEC. There are several FVECs defined, namely FVEC0.x, FVEC1.x, FVEC2.x, FVEC3.x and FVEC7.x. The

letter „x“ is a placeholder for the sub functions of the FVECs. „x“ can be a number between 1 and 255. Please note not all sub numbers are valid.

- FVEC0.x: This interface establishes the contactless communication according to ISO/IEC 14443 for the Security IC Embedded Software. Furthermore it provides sub functions to enable MIFARE Software.
- FVEC1.x: This interface is used to access the EEPROM owned by MIFARE Plus MF1PLUSx0 when in security level 1 or security level 2. MIFARE Plus MF1PLUSx0 in security level 1 or security level 2 does not implement any Security Functional Requirement and therefore FVEC1.x is not in the scope of the evaluation.
- FVEC2.x: This interface provides the service to seal/unseal user data in a defined memory area using the Physical Unclonable Function (PUF) block. This interface is also used to read/clear the attack detector status and to read the error counter value.
- FVEC3.x: This interface is used to access the EEPROM owned by MIFARE DESFire EV1 or MIFARE Plus MF1PLUSx0 (MIFARE Software). It only handles MIFARE Software commands specified for ISO14443-4. For MIFARE Plus MF1PLUSx0, this includes all security level 0 and security level 3 commands and the security level switch commands in security level 1 and security level 2.
- FVEC7.x: This interface implements programming of the internal EEPROM memory, which is mandatory for use by the Security IC Embedded Software when programming the EEPROM memory.
- The MIFARE Plus MF1PLUSx0 provides the following functionality:
 - A data storage system that contains blocks grouped in sectors which can store data (including so-called values which are blocks in a specific format representing a number).
 - Authentication on sector level with fine-grained access conditions blocks.
 - Message authentication to support replay attack protection.
 - Data encryption for confidentiality of the contact-less communication.
 - Unique serial number for each device (UID) with optional random UID.
 - MIFARE Plus MF1PLUSx0 offers four security levels, but can only be in one security level at a time. The main features of each security level are listed below:
 - Security Level 0: no security functionality, import of keys for further levels, cannot be used for other purposes, and
 - Security Level 1: no security functionality, authentication procedure acc. to MIFARE Classic protocol,
 - Security Level 2: AES-based authentication procedure acc. to MIFARE Classic protocol, not part of the FOS version 0C.60, and
 - Security Level 3: provides security services, AES-based authentication procedure, secure massaging, cannot be switched back to another level.

- The P6022M VB/P6022J VB provides the Security Services assigned to the MIFARE Plus MF1PLUSx0 in security level 3. In addition the personalisation in security level 0, the originality function, which allows verifying the authenticity of the P6022M VB/P6022J VB in all security levels, as well as the switching from security level 1 and security level 2 into security level 3 are within the scope of the evaluation. Note: Communication with the card terminal in security level 1 and security level 2 use the proprietary MIFARE Classic protocol, which do not implement any Security Functional Requirement and is therefore not in the scope of the evaluation.
- The MIFARE Plus MF1PLUSx0 security level 0 is intended for personalisation in phase 6. The security levels 1 to 3 are intended for the phase 7 of the Security IC product life-cycle.
- The MIFARE DESFire provides the following functionality:
 - Flexible file system that can contain up to 28 applications with up to 32 files in each application,
 - Support for different file types like values or data records,
 - Mutual three pass authentication, also according to ISO 7816-4,
 - Authentication on application level with fine-grained access conditions for files,
 - Multi-application support that allows distributed management of applications and ensures application segregation,
 - Data encryption for contact-less communication with replay attack protection,
 - Transaction system with rollback that ensures consistency for complex transactions,
 - Unique serial number for each device (UID) with optional random UID,
 - The additional SFRs for MIFARE DESFire EV1 are defined in Section 6.1.2.2. of the Security Target. The additional SFRs for the MIFARE DESFire EV1 software include the iteration indicator "[DF]" to clearly mark that they are only applicable for the MIFARE DESFire EV1 software,
 - The P6022D VB/P6022J VB supports a MIFARE DESFire EV1 backward compatible mode for authentication. The backward compatible mode for authentication is not part of any Security Functional Requirement of MIFARE DESFire EV1 and is therefore not in the scope of the evaluation, and
 - The P6022D VB/P6022J VB support MIFARE DESFire EV1 authentication with 2-key Triple-DES. The 2-key Triple-DES authentication is not part of any Security Functional Requirement of MIFARE DESFire EV1 and is therefore also not in the scope of the evaluation.

6. Documentation

The evaluated documentation as outlined in table 2 is being provided with the product to the customer. This documentation contains the required information for secure usage of the TOE in accordance with the Security Target.

Additional obligations and notes for secure usage of the TOE as outlined in chapter 10 of this report have to be followed.

7. IT Product Testing

The developers' testing effort can be summarised in the following aspects.

TOE test configuration and Developer's testing approach:

- The tests are performed with the TOE in different test environments and configurations depending on the test classes and groups.
- All TSF and related security mechanisms, subsystems and modules are tested in order to assure complete coverage of all SFR.
- Test categories for P6022P/X VB (EAL6):
 - Production testing on wafers using test functions implemented in the IC Dedicated Software. These test functions are accessed via test commands, which are issued by the production tests. Test functions respond signatures to the production tests. Production tests also apply signals to and/or measures signals at any contact of the device. Final test or module test therefore is limited to a verification of electrical connections like checking the pins of the package for shorts and opens.
 - Simulation tests (design verification): Simulation tests are performed to verify functionality, which is not visible at the accessible interfaces of the TOE. These simulation tests are a subset of those, which were performed during development of the device to ensure a proper design of its modules.
 - During run-time of a simulation an automated regression test continuously compares pre-defined internal signals (probe list) like data and address buses, control signals, register contents and microcode information against a "golden reference". Test results are automatically listed in log files and a summary, i.e. discrepancies occurred (yes/no), is output to the user interface.
 - Manual simulation tests are performed in case an automated result comparison based on executable code is not possible.
 - Characterization tests: Characterization tests verify the electrical properties of the device, which are specified with regard to limiting values, thresholds and timings of several electrical parameters like voltages, currents, frequencies, capacitors, resistances and latches. For this purpose a number of devices for test are taken from production.
 - Verification tests: Verification tests are performed on single samples of the device to verify specific security functionality, which is not testable for each device during production test or within the scope of characterization testing. Such tests include standard tests of the Random Number Generator, AES coprocessor and Triple-DES coprocessor.
- Additional test categories for P6022M VB, P6022D VB, and P6022J VB:
 - Functional verification and validation (MIFARE MF1PLUSx0 and MIFARE DESFire EV1) including firmware tests, MIFARE Plus Acceptance/Regression Tests, MIFARE Plus Backwards Compatibility Tests, Anti-Tearing Test.

- System Stability Verification (MIFARE MF1PLUSx0 and MIFARE DESFire EV1) including Robot Arm test and Multiple PICC Test.
- Performance Verification (MIFARE MF1PLUSx0 and MIFARE DESFire EV1) of each individual command and of standard transactions.
- External test (MIFARE MF1PLUSx0 and MIFARE DESFire EV1), consisting of a “Test plan for MIFARE® Compatibility for Certification of Terminals and Qualification of Contactless Readers”.

Independent Testing according to ATE_IND

Testing approach:

- The evaluator's objective regarding this aspect was to test the functionality of the TOE as described for all available TOE configurations and to verify the developer's test results by repeating developer's tests and additionally add independent tests.
- In the course of the evaluation of the TOE the following classes of tests were carried out:
 - Module tests,
 - Simulation tests,
 - Emulation tests,
 - Tests in user mode,
 - Tests in test mode, and
 - Hardware tests.
- With this kind of tests the entire security functionality of the TOE was tested.

Penetration Testing according to AVA_VAN

Overview:

- The penetration testing was partially performed using the developer's testing environment, partially using the test environment of the evaluation body.
- All configurations of the TOE being intended to be covered by the current evaluation were tested.
- The overall test result is that no deviations were found between the expected and the actual test results; moreover, no attack scenario with the attack potential high was actually successful.

Penetration testing approach:

- Systematic search for potential vulnerabilities and known attacks in public domain sources, use of a list of vulnerabilities, and from a methodical analysis of the evaluation documents.
- Analysis why these vulnerabilities are unexploitable in the intended environment of the TOE.
- If the rationale is suspect in the opinion of the evaluator penetration tests are devised.

- Even if the rationale is convincing in the opinion of the evaluator penetration tests are devised for some vulnerabilities, especially to support the argument of non-practicability of exploiting time in case of SPA, DPA and FI attacks.

8. Evaluated Configuration

The P6022y VB hardware platform was tested including all minor configuration options that can be selected based on the Security Target. All minor configurations are available to the evaluator. The major configuration does not have dependencies to security features. All minor configuration options that are part of the evaluation were tested. The minor configuration options behave as specified and described in [12] and [13].

The major and minor configurations cannot be influenced by the customer. They are selected by the customer according to the Order Entry Form. This configuration cannot be changed in the Application Mode after delivery of the TOE.

The Mifare Classic configurations MC1 and MC4 do not implement any Security Functional Requirement for MIFARE Plus MF1PLUSx0 and the functionality provided by the IC Dedicated Software when configured to MC1 and MC4 was not part of the evaluation process.

9. Results of the Evaluation

9.1. CC specific results

The Evaluation Technical Report (ETR) [7] was provided by the ITSEF according to the Common Criteria [1], the Methodology [2], the requirements of the Scheme [3] and all interpretations and guidelines of the Scheme (AIS) [4] as relevant for the TOE.

The Evaluation Methodology CEM [2] was used for those components up to EAL 5 extended by advice of the Certification Body for components beyond EAL 5 and guidance specific for the technology of the product [4] (AIS 34).

The following guidance specific for the technology was used:

- (i) *The Application of CC to Integrated Circuits*
- (ii) *Application of Attack Potential to Smartcards*
- (iii) *Guidance, Smartcard Evaluation*

(see [4], AIS 25, AIS 37).

For RNG assessment the scheme interpretations AIS 31 was used (see [4]).

To support composite evaluations according to AIS 36 the document ETR for composite evaluation [10] was provided and approved. This document provides details of this platform evaluation that have to be considered in the course of a composite evaluation on top.

As a result of the evaluation the verdict PASS is confirmed for the following assurance components:

For P6022P/X VB:

- All components of the EAL 6 package including the class ASE as defined in the CC (see also part C of this report)

- The components ALC_FLR.1 and ASE_TSS.2 augmented for this TOE evaluation.

For P6022M/D/J VB:

- All components of the EAL 5 package including the class ASE as defined in the CC (see also part C of this report)
- The components AVA_VAN.5, ALC_DVS.2 and ASE_TSS.2 augmented for this TOE evaluation.

The evaluation has confirmed:

- PP Conformance: Security IC Platform Protection Profile with Augmentation Packages Version 1.0, 13 January 2014, BSI-CC-PP-0084-2014 [8]
- for the Functionality: PP conformant plus product specific extensions
Common Criteria Part 2 extended
- for the Assurance: Common Criteria Part 3 conformant
P6022P/X VB: EAL6 augmented by ALC_FLR.1, ASE_TSS.2
P6022M/D/J VB: EAL 5 augmented by AVA_VAN.5, ALC_DVS.2, ASE_TSS.2

For specific evaluation results regarding the development and production environment see annex B in part D of this report.

The results of the evaluation are only applicable to the TOE as defined in chapter 2 and the configuration as outlined in chapter 8 above.

9.2. Results of cryptographic assessment

The strength of the cryptographic algorithms was not rated in the course of this certification procedure (see BSIG Section 9, Para. 4, Clause 2). But Cryptographic Functionalities with a security level of lower than 100 bits can no longer be regarded as secure without considering the application context. Therefore, for these functionalities it shall be checked whether the related crypto operations are appropriate for the intended system. Some further hints and guidelines can be derived from the 'Technische Richtlinie BSI TR-02102' (<https://www.bsi.bund.de>).

Any Cryptographic Functionality that is marked in column '*Security Level above 100 Bits*' of the following table with '*no*' achieves a security level of lower than 100 Bits (in general context).

10. Obligations and Notes for the Usage of the TOE

The documents as outlined in table 2 contain necessary information about the usage of the TOE and all security hints therein have to be considered. In addition all aspects of Assumptions, Threats and OSPs as outlined in the Security Target not covered by the TOE itself need to be fulfilled by the operational environment of the TOE.

The customer or user of the product shall consider the results of the certification within his system risk management process. In order for the evolution of attack methods and techniques to be covered, he should define the period of time until a re-assessment of the TOE is required and thus requested from the sponsor of the certificate.

Some security measures are partly implemented in the hardware and require additional configuration or control or measures to be implemented by the IC Dedicated Support Software or Embedded Software.

For this reason the TOE includes guidance documentation (see table 2) which contains guidelines for the developer of the IC Dedicated Support Software and Embedded Software on how to securely use the microcontroller chip and which measures have to be implemented in the software in order to fulfil the security requirements of the Security Target of the TOE.

In the course of the evaluation of the composite product or system it must be examined if the required measures have been correctly and effectively implemented by the software. Additionally, the evaluation of the composite product or system must also consider the evaluation results as outlined in the document ETR for composite evaluation [10].

In addition, the following aspect needs to be fulfilled when using the TOE:

The implementation of the encryption/decryption operation of the MIFARE Plus MF1PLUSx0 may expose some bits of the XOR difference between pairs of plaintext using the principles of a watermark attack.

11. Security Target

For the purpose of publishing, the Security Target [9] of the Target of Evaluation (TOE) is provided within a separate document as Annex A of this report. It is a sanitised version of the complete Security Target [6] used for the evaluation performed. Sanitisation was performed according to the rules as outlined in the relevant CCRA policy (see AIS 35 [4]).

12.2. Glossary

Augmentation - The addition of one or more requirement(s) to a package.

Collaborative Protection Profile - A Protection Profile collaboratively developed by an International Technical Community endorsed by the Management Committee.

Extension - The addition to an ST or PP of functional requirements not contained in CC part 2 and/or assurance requirements not contained in CC part 3.

Formal - Expressed in a restricted syntax language with defined semantics based on well-established mathematical concepts.

Informal - Expressed in natural language.

Object - A passive entity in the TOE, that contains or receives information, and upon which subjects perform operations.

Package - named set of either security functional or security assurance requirements

Protection Profile - A formal document defined in CC, expressing an implementation independent set of security requirements for a category of IT Products that meet specific consumer needs.

Security Target - An implementation-dependent statement of security needs for a specific identified TOE.

Semiformal - Expressed in a restricted syntax language with defined semantics.

Subject - An active entity in the TOE that performs operations on objects.

Target of Evaluation - An IT Product and its associated administrator and user guidance documentation that is the subject of an Evaluation.

TOE Security Functionality - Combined functionality of all hardware, software, and firmware of a TOE that must be relied upon for the correct enforcement of the SFRs.

C. Excerpts from the Criteria

CC Part 1:

Conformance Claim (chapter 10.4)

“The conformance claim indicates the source of the collection of requirements that is met by a PP or ST that passes its evaluation. This conformance claim contains a CC conformance claim that:

- describes the version of the CC to which the PP or ST claims conformance.
- describes the conformance to CC Part 2 (security functional requirements) as either:
 - **CC Part 2 conformant** - A PP or ST is CC Part 2 conformant if all SFRs in that PP or ST are based only upon functional components in CC Part 2, or
 - **CC Part 2 extended** - A PP or ST is CC Part 2 extended if at least one SFR in that PP or ST is not based upon functional components in CC Part 2.
- describes the conformance to CC Part 3 (security assurance requirements) as either:
 - **CC Part 3 conformant** - A PP or ST is CC Part 3 conformant if all SARs in that PP or ST are based only upon assurance components in CC Part 3, or
 - **CC Part 3 extended** - A PP or ST is CC Part 3 extended if at least one SAR in that PP or ST is not based upon assurance components in CC Part 3.

Additionally, the conformance claim may include a statement made with respect to packages, in which case it consists of one of the following:

- Package name Conformant - A PP or ST is conformant to a pre-defined package (e.g. EAL) if:
 - the SFRs of that PP or ST are identical to the SFRs in the package, or
 - the SARs of that PP or ST are identical to the SARs in the package.
- Package name Augmented - A PP or ST is an augmentation of a predefined package if:
 - the SFRs of that PP or ST contain all SFRs in the package, but have at least one additional SFR or one SFR that is hierarchically higher than an SFR in the package.
 - the SARs of that PP or ST contain all SARs in the package, but have at least one additional SAR or one SAR that is hierarchically higher than an SAR in the package.

Note that when a TOE is successfully evaluated to a given ST, any conformance claims of the ST also hold for the TOE. A TOE can therefore also be e.g. CC Part 2 conformant.

Finally, the conformance claim may also include two statements with respect to Protection Profiles:

- PP Conformant - A PP or TOE meets specific PP(s), which are listed as part of the conformance result.

Evaluation assurance levels (chapter 8)

“The Evaluation Assurance Levels (EALs) provide an increasing scale that balances the level of assurance obtained with the cost and feasibility of acquiring that degree of assurance. The CC approach identifies the separate concepts of assurance in a TOE at the end of the evaluation, and of maintenance of that assurance during the operational use of the TOE.

It is important to note that not all families and components from CC Part 3 are included in the EALs. This is not to say that these do not provide meaningful and desirable assurances. Instead, it is expected that these families and components will be considered for augmentation of an EAL in those PPs and STs for which they provide utility.”

Evaluation assurance level (EAL) overview (chapter 8.1)

“Table 1 represents a summary of the EALs. The columns represent a hierarchically ordered set of EALs, while the rows represent assurance families. Each number in the resulting matrix identifies a specific assurance component where applicable.

As outlined in the next Section, seven hierarchically ordered evaluation assurance levels are defined in the CC for the rating of a TOE’s assurance. They are hierarchically ordered inasmuch as each EAL represents more assurance than all lower EALs. The increase in assurance from EAL to EAL is accomplished by substitution of a hierarchically higher assurance component from the same assurance family (i.e. increasing rigour, scope, and/or depth) and from the addition of assurance components from other assurance families (i.e. adding new requirements).

These EALs consist of an appropriate combination of assurance components as described in Chapter 7 of this CC Part 3. More precisely, each EAL includes no more than one

component of each assurance family and all assurance dependencies of every component are addressed.

While the EALs are defined in the CC, it is possible to represent other combinations of assurance. Specifically, the notion of “augmentation” allows the addition of assurance components (from assurance families not already included in the EAL) or the substitution of assurance components (with another hierarchically higher assurance component in the same assurance family) to an EAL. Of the assurance constructs defined in the CC, only EALs may be augmented. The notion of an “EAL minus a constituent assurance component” is not recognised by the standard as a valid claim. Augmentation carries with it the obligation on the part of the claimant to justify the utility and added value of the added assurance component to the EAL. An EAL may also be augmented with extended assurance requirements.

Evaluation assurance level 1 (EAL 1) - functionally tested (chapter 8.3)

“Objectives

EAL 1 is applicable where some confidence in correct operation is required, but the threats to security are not viewed as serious. It will be of value where independent assurance is required to support the contention that due care has been exercised with respect to the protection of personal or similar information.

EAL 1 requires only a limited security target. It is sufficient to simply state the SFRs that the TOE must meet, rather than deriving them from threats, OSPs and assumptions through security objectives.

EAL 1 provides an evaluation of the TOE as made available to the customer, including independent testing against a specification, and an examination of the guidance documentation provided. It is intended that an EAL 1 evaluation could be successfully conducted without assistance from the developer of the TOE, and for minimal outlay.

An evaluation at this level should provide evidence that the TOE functions in a manner consistent with its documentation.”

Evaluation assurance level 2 (EAL 2) - structurally tested (chapter 8.4)

“Objectives

EAL 2 requires the co-operation of the developer in terms of the delivery of design information and test results, but should not demand more effort on the part of the developer than is consistent with good commercial practise. As such it should not require a substantially increased investment of cost or time.

EAL 2 is therefore applicable in those circumstances where developers or users require a low to moderate level of independently assured security in the absence of ready availability of the complete development record. Such a situation may arise when securing legacy systems, or where access to the developer may be limited.”

Evaluation assurance level 3 (EAL 3) - methodically tested and checked (chapter 8.5)

“Objectives

EAL 3 permits a conscientious developer to gain maximum assurance from positive security engineering at the design stage without substantial alteration of existing sound development practises.

EAL 3 is applicable in those circumstances where developers or users require a moderate level of independently assured security, and require a thorough investigation of the TOE and its development without substantial re-engineering.”

Evaluation assurance level 4 (EAL 4) - methodically designed, tested, and reviewed (chapter 8.6)

“Objectives

EAL 4 permits a developer to gain maximum assurance from positive security engineering based on good commercial development practises which, though rigorous, do not require substantial specialist knowledge, skills, and other resources. EAL 4 is the highest level at which it is likely to be economically feasible to retrofit to an existing product line.

EAL 4 is therefore applicable in those circumstances where developers or users require a moderate to high level of independently assured security in conventional commodity TOEs and are prepared to incur additional security-specific engineering costs.”

Evaluation assurance level 5 (EAL 5) - semiformally designed and tested (chapter 8.7)

“Objectives

EAL 5 permits a developer to gain maximum assurance from security engineering based upon rigorous commercial development practises supported by moderate application of specialist security engineering techniques. Such a TOE will probably be designed and developed with the intent of achieving EAL 5 assurance. It is likely that the additional costs attributable to the EAL 5 requirements, relative to rigorous development without the application of specialised techniques, will not be large.

EAL 5 is therefore applicable in those circumstances where developers or users require a high level of independently assured security in a planned development and require a rigorous development approach without incurring unreasonable costs attributable to specialist security engineering techniques.”

Evaluation assurance level 6 (EAL 6) - semiformally verified design and tested (chapter 8.8)

“Objectives

EAL 6 permits developers to gain high assurance from application of security engineering techniques to a rigorous development environment in order to produce a premium TOE for protecting high value assets against significant risks.

EAL 6 is therefore applicable to the development of security TOEs for application in high risk situations where the value of the protected assets justifies the additional costs.”

Evaluation assurance level 7 (EAL 7) - formally verified design and tested (chapter 8.9)

“Objectives

EAL 7 is applicable to the development of security TOEs for application in extremely high risk situations and/or where the high value of the assets justifies the higher costs. Practical application of EAL 7 is currently limited to TOEs with tightly focused security functionality that is amenable to extensive formal analysis.”

Class AVA: Vulnerability assessment (chapter 16)

“The AVA: Vulnerability assessment class addresses the possibility of exploitable vulnerabilities introduced in the development or the operation of the TOE.”

Vulnerability analysis (AVA_VAN) (chapter 16.1)

“Objectives

Vulnerability analysis is an assessment to determine whether potential vulnerabilities identified, during the evaluation of the development and anticipated operation of the TOE or by other methods (e.g. by flaw hypotheses or quantitative or statistical analysis of the security behaviour of the underlying security mechanisms), could allow attackers to violate the SFRs.

Vulnerability analysis deals with the threats that an attacker will be able to discover flaws that will allow unauthorised access to data and functionality, allow the ability to interfere with or alter the TSF, or interfere with the authorised capabilities of other users.”
